Contemporary extractivism in Latin America 1: representations and reconceptualizations

This panel explores manifestations of contemporary extractivism in Latin America, as well the ways in which it can be conceptualized and represented. Extractivism goes beyond extractive industries (mining, oil, and gas) and may be better understood as a logic of rent capture that involves the extraction of natural resource rents without restoration of those resources nor of the socio-natural relations that they previously sustained. Extractivism can be manifest, then, as development strategies based on synergies between infrastructure, extractive industry, agro-industry, extensive ranching and similar, as well as in the form of smaller scale activities operating with logics of rent capture without restoration or care. Alternatives to extractivism refer not only to alternative economic activities, but also to alternatives logics based not on rent capture but diverse forms of socio-natural cohabitation. The academy, civil society, private and public sector actors have represented extractivism and its alternatives in diverse ways. The papers in this panel document a range of extractivisms and alternatives, and diverse means of representing and conceptualizing these. Centroamerica a la Sevillana: The Work of Central American Doctoral Graduates of the Universidad Pablo de Olavide in Seville

Since its founding in 1997, less than a quarter-century ago, the Universidad Pablo de Olavide (UPO) in Seville has developed in leaps and bounds. Nowhere is this more emblematically so than in UPO's doctoral program in Latin American history, from which (to date) some 150 students have graduated with a PhD, the majority of them from far-flung parts of Latin America itself. This panel features presentations by four recent graduates of the program – one from Costa Rica, one from Guatemala, and two from El Salvador. Magda Angélica García von Hoegen draws on her work among the youth of Verapaz, Guatemala, to highlight processes of cultural continuity and adaptation operating in their tight-knit communities. Ana Sofía Solano Acuña discusses the resistance mounted by the indigenous Guaymí of Panama to protect their lands and livelihoods, culture and identity in the face of outside intrusions in the late nineteenth and early twentieth centuries. For El Salvador, José Heriberto Erquicia Cruz examines indigo production

and the dye's global importance in the second half of the eighteenth and early nineteenth centuries. Also focusing on El Salvador in the eighteenth century, Ricardo Castellon reconstructs family dynamics and mobility as part of a larger study charting demographic and ethnic change.
